This camera series shares a similar structure. We take one type among this series for demonstration.

Make sure that the device in the package is in good condition and all the assembly parts are included.

Make sure wall is strong enough to withstand at least four times the weight of the device and the mount.

The standard power supply is 12 VDC or 24 VAC or PoE. Make sure your power supply matches your device.

Make sure that the power has been disconnected before you wire, install, or disassemble the device.

Make sure that no reflective surface is too close to the device lens. The IR light from the device may reflect back into the lens causing reflection.


